The project doesn't have to start from scratch either, but builds on the strong foundations of GNU Taler — the privacy-preserving digital payment system developed by the GNU community and Taler Systems SA. This offers privacy for those that make payments, while enforcing transparency on those that sell. By providing micro payments at very low overhead, GNU Taler permits internet business models to shift away from advertising revenue or subscription models, especially for online publishers. No-risk transactions can lower transaction fees and open online payments for the underbanked population and citizens marginalized from digitalisation.

It wants to provide everyone with high-quality, secure IT systems for everyday use. Without tracking, without exploitation, in a way that runs everywhere and scales effortlessly. Fediversity is based on NixOS, a disruptive Linux distribution with a unique approach to package and configuration management.
	Built on top of the Nix package manager, NixOS is completely declarative, makes upgrading systems reliable, and has many other advantages. Because it is reproducible, it is ideally suited for complex deployment scenario's where consistent behaviour, stability and configurability matter.
Description:	One such "complex" deployment scenario is running state-of-the-art services for the Fediverse, like PeerTube, Mastodon, Owncast or Lemmy — especially if you want to for instance add services like live chat or transcoding. But even running more traditional services like modern e-mail servers with possible whistles and bells can be daunting.
	The same holds for deploying a VPN, private cloud storage, wiki, etc. Fediversity will enable all of these use cases, and more — finally bringing these to the market in a way that is as conveient as using a hosted service.

1. Horizon Europe Work Programme 2025

New Horizon Europe Work Programme has been published. Food, Bioeconomy, Ntural Resources, Agriculture and Environment

2. European Defence Fund: Work Programme 2025 published

On 30 January, the EU Commission published the 2025 Work Programme of the European Defence Fund (EDF). With a budget of EUR 1.065 billion, it covers 33 topics which contain seven thematic calls and two non-thematic calls for proposals, supplemented by two measures to support the Alliance for Defence Medical Countermeasures.

3. Public consultation on the European Water Resilience Strategy

The EU Commission has started a public consultation to gather feedback for a Water Resilience Strategy. Different stakeholders, including universities, researchers and innovation policymakers, have until 4 March 2025 to provide their input to this initiative. The results of the consultation will be incorporated in the Commission Communication on the European Water Resilience Strategy. The cross-sectoral and long-term strategy aims to ensure that water sources are properly managed and to combat water scarcity. Further objectives are the expansion of the water industry and greater use of the circular economy. In addition, the EU Commission will be holding a stakeholder workshop on 6 March 2025 as part of the European Ocean Days (3-7 March) in Brussels. 4. Knowledge Valorisation: European Commission seeks input on Socially Responsible Licensing

The EU Commission's Directorate General for Research and Innovation (RTD) has launched a <u>survey</u> to collect experiences on Socially Responsible Licensing practices. It is mainly addressed to professionals working in and with universities and public research organisations. The initiative comes under the EU Commission's efforts to boost Knowledge Valorisation of its funded projects, which is likely to gain further importance within the next EU Framework Programme. Within the EU context, the concept of Knowledge Valorisation goes beyond the more traditional tech transfer and also includes societal considerations. There is also a Horizon Europe funded project on Impact Licensing which was launched last year. More information here

5. Magna Charta Observatory's Work and Upcoming Events

The original Magna Charta Universitatum (MCÜ) was first signed by 388 universities from around the world in 1988 on the 900th anniversary of the founding of the University of Bologna. The document contained the fundamental principles of academic freedom and institutional autonomy. Its purpose was to guide universities in achieving good governance and self-understanding in the future. Its purpose was to guide universities in achieving good governance and self-understanding in the future. Since then, universities and the environments in which they operate have changed greatly. In the context of these changes, a multi-national group was formed to review the Magna Charta Universitatum which consulted globally. The outcome of this collective effort was a revised MCU which was adopted by the Governing Council of the Magna Charta Observatory (MCO) in July 2020. The new MCU is a document for the higher education sector which was prepared by the sector. While preserving the essence of the original foundational document, the revised MCU strives to be responsive to and resonate with contemporary challenges and concerns. Its tone recognises that the pursuit of the fundamental values has worth along with their actual attainment, which, in practice, is a constant quest. Moreover, it recognises the more global nature of what universities do and the wider range of local responsibilities which they have in serving local communities. To date, nearly 1000 universities from 94 countries have signed either one or other version of the MCU.

- Recent and Upcoming Conferences: Following the success of our 2023 Anniversary Conference in Poland on the
 role of universities in reconstruction and our 2024 Anniversary Conference in Washington, D.C., on "Universities,
 Governments, and Democracy," the 2025 Anniversary Conference in London (11-13 November) will explore the theme:
 "What Are Universities For? Higher Education Principles, Values, and Responsibilities in a Fragmented World." We
 welcome your participation; further details and registration information will follow.
- Research & Publications: The results of our research on *The Responsive and Responsible University* will soon be published, with a free book available at the 2025 MCU Anniversary in London.
- Student Engagement: Building on the success of our annual essay competition (97 entries from 24 countries in 2023, 144 entries from 45 countries in 2024), we are preparing the 2025 edition with a new theme and developing resources to help student leaders contribute more effectively to their universities.
- Strategic Vision 2025-2030: The MCO Council is finalizing its new strategy, setting a roadmap for how the Observatory will serve universities in the future. This will be published soon on our website.
